### Article 71 1. (a) - Courts for application for a declaration of enforceability and courts for appeal against decisions on such applications

#### Article 71 1. (b) - Redress procedure

Our judicial system provides for a court of third instance, namely a way to contest a decision given on appeal, under certain conditions.

#### Article 71 1. (c) - Review procedure

A review of the kind provided for in this Article can be sought by way of an application to set aside the decision (*aítisi paramerismou tis apófasis*) pursuant to provision 48, rule 9(h) and (n) of the Rules of Civil Procedure (*Thesmoí Politikís Dikonomías*). The application is lodged with the Family Court which issued the decision to be set aside.
