### Article 67 (b)

For the purposes of Article 57(2), the languages accepted are Greek and English.

### Article 67 (c)

For the certificate concerning right of access and the child's return (Article 45(2)), the languages accepted are Greek and English.

### Articles 21 and 29

Applications under Articles 21 and 29 are to be submitted to the following courts:

- Nicosia Family Court (*Οικογενειακό Δικαστήριο Λευκωσίας*)
- Limassol Family Court (*Οικογενειακό Δικαστήριο Λεμεσού*)
- Larnaca/Famagusta Family Court (*Οικογενειακό Δικαστήριο Λάρνακας-Αμμοχώστου*)
- Paphos Family Court (*Οικογενειακό Δικαστήριο Πάφου*)

### Article 33

Appeals under Article 33 are to be lodged with the Family Court of Appeal (*Δευτεροβάθμιο Οικογενειακό Δικαστήριο*).

### Article 34

In Cyprus, for the purposes of Article 34, there is no means of contest by which a judgment given on appeal can be contested before a court of third instance.
